1. ALL BOATS MUST MEET COAST GUARD SAFETY REQUIREMENTS, ANY VIOLATION OF THE WATERWAYS WILL RESULT IN DISQUALIFICATION.
2. CONTESTANTS ARE REQUIRED TO WEAR A LIFE PRESERVER, AND KILL SWITCH ANYTIME THE GASOLINE MOTOR IS ON PLAIN.
3. NO ALCOHOLIC BEVERAGES IN BOAT DURING THE TOURNAMENT OR WEIGH-IN.
4. LIVE WELLS WILL BE CHECKED, LIVE BAIT OR TROLLING IS NOT PERMITTED.
5. EACH BOAT MUST CHECK-OUT AND CHECK-IN BY BOAT NUMBER.
6. FISHING ON TOURNAMENT WATERS IS PERMITTED ANYWHERE EXCEPT WITHIN 50 YARDS FROM A MARINA GAS DOCK OR ANOTHER CONTESTANTS BOAT IF HE/SHE IS ANCHORED AND TROLLING MOTOR IS UP.
7. **5 FISH LIMIT PER BOAT, LARGE MOUTH AND SPOTTED BASS ONLY.**
8. MINIMUM LENGTH OF FISH IS 12 INCHES FOR SPOTTED BASS AND 14 INCHES FOR LARGE MOUTH BASS ON A GOLDEN RULE MOUTH CLOSED SWEPT TAIL.
9. IF MORE THAN 5 FISH ARE BROUGHT TO THE SCALES, FISH WILL BE CULLED TO 5 BEGINNING WITH THE LARGEST FISH.
10. BOATER WEIGHING IN A SHORT FISH WILL LOSE THE SHORT FISH AND ALSO RECEIVE A ONE POUND PENALTY FOR EACH SHORT FISH.
11. THERE WILL BE AN 8 OUNCE PENALTY FOR ANY DEAD FISH WEIGHED IN AND THE WEIGH MASTER WILL USE HIS/HER DISCRETION ON DEAD FISH BEING COUNTED
12. ANY PROTEST MUST BE DONE NO LATER THAN 30 MINUTES AFTER WEIGH IN IS OVER
13. ANY AND ALL TIES WILL BE DECIDED BY ADDING PRIZE MONEY TOGETHER AND DIVIDED.
14. ALL BOATS THAT CHECK-IN LATE WILL BE ASSESSED ONE POUND PER MINUTE, AFTER 10 MINUTES THE CONTESTANTS WILL BE DISQUALIFIED.
15. CONSENT TO TAKE THE POLYGRAPH TEST IS CONSIDERD GIVEN ON SIGNING THE ENTRY FORM.
16. A CHILD IS CONSIDERED TO BE THAT PERSON 16 YEARS OF AGE OR YOUNGER.
